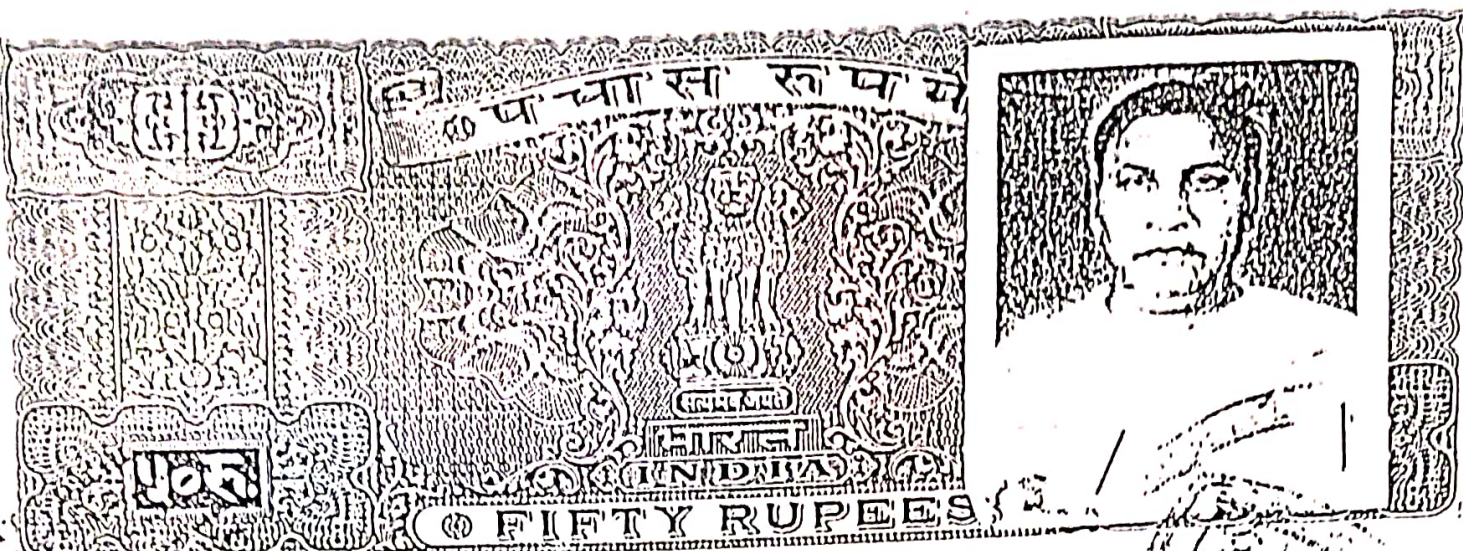




SUPPLEMENTARY TRUST DEED
